**Terms and Conditions**

Please read these very carefully. You need to sign your assent to the following booking conditions on the booking form.

Our promises to you:

- We aim to be fair, reasonable and sympathetic in all our dealings with you
- We will meet all our legal and regulatory responsibilities, aiming to go beyond the minimum obligations
- We aim to provide full and accurate information about the festival and any changes will be communicated promptly
- If something goes wrong, we will try to put it right. Our aim is to ensure that each guests is happy with their Festival experience

**Contract:** From the moment we receive your signed booking form and initial payment, a contract exists between you and the Pharos Arts Foundation.

**Insurance:** It is advisable to have travel insurance. It can be obtained from most insurance companies, banks and travel agencies.

**Passports & visas:** Travelling to Cyprus is very easy. The documentation required varies, depending on nationality. A valid passport (valid for six months beyond the date of the Festival) is required for a stay of up to 90 days for all bona fide tourists except citizens of European Union countries, Switzerland, Iceland, Liechtenstein and Norway who may enter Cyprus with their national identity card provided it bears a recent photo. Nationals of other countries should check with their local embassy / consulate and obtain visas if required.

**Cancellation:** If you have to cancel your participation, please let us know immediately. If you cancel less than 2 weeks before the arrival date, we reserve the right to deduct a cancellation fee of 50%.

If we cancel the Festival due to insufficient bookings or another reason resulting from the Pharos Arts Foundation, you will receive a full refund. This does not apply in the case of force majeure circumstances beyond our control.

**Changes:** Circumstances may arise which prevent us from operating the Festival as advertised. We will communicate these changes to you promptly, and we will make every effort to provide appropriate alternatives.

**Cyprus law:** These conditions form part of your contract with the Pharos Arts Foundation and are governed by Cyprus Law.
